The Parish Council has the following concerns: - the size and projection of the roof would constitute a visual intrusion in to the open character of the area and would have an adverse impact on the street scene.

10/07792/FUL: Land Between Scalene And Harvest Barn Thame Road Longwick Buckinghamshire Proposed: Erection of single storey 3 bed semi subterranean dwelling and new access. The Parish Council recommends this new application is refused on the grounds that it still contravenes Policy C10 of the Wycombe District Local Plan in that the proposed site lies outside the defined boundary of Longwick and the proposed development would be detrimental to the setting of the immediately adjacent listed buildings and as such, would have an adverse effect on the street scene and character of the area.

11/05022/FUL: Armour Farm Barn, Stockwell Lane, Little Meadle.

**Proposed:** Householder application for construction of first floor extension over existing garage and associated external and internal alterations. **The Parish Council has no objections.** 

11/05044/FUL: Ivy Farm Lower Icknield Way Longwick

**Proposed:** Construction of detached barn to winter cattle and /or sheep

The Parish Council has no objections providing the use of the barn is restricted for agricultural purposes only.
